MESSAGE FROM PROFESSOR NOEL WHELAN, CHAIRMAN, ST. VINCENT'S HEALTHCARE GROUP

I am delighted to welcome all readers to this, the 6th, issue of the Friends of St. Vincent's Magazine. This magazine is designed to inform the many people who loyally support St. Vincent's fundraising, in these difficult times, of current developments relating to St. Vincent's Foundation and St. Vincent's Healthcare Group,

St. Vincent's Healthcare Group, and its constituent hospitals (St. Vincent's University Hospital; St. Michael's Hospital, Dun Laoghaire; and St. Vincent's Private Hospital), has come about from a rich tradition. Since the original hospital (St. Vincent's Hospital) was founded by Mother Mary Aikenhead in St. Stephen's Green, Dublin 2 in January 1834, patient care has undergone much change. When it was opened, St. Vincent's could accommodate twelve patients! Today, St. Vincent's University Hospital has in excess of five hundred beds, with over eight hundred in total in the three constituent hospitals which make up St. Vincent's Healthcare Group. The patient throughput nowadays is in excess of 158,000 per year

Much has changed also in medical research. Here, in partnership with universities, many advances are being achieved in medical diagnosis and treatments. These partnerships between hospitals and academic institutions are very important in realising what is described as "bench to bedside" delivery of care... or translational research. St. Vincent's is justifiably proud of the role it has played in developing medical knowledge. It has over 500 operating agreements with hospitals of excellence worldwide.

In education, also, the hospitals in the St. Vincent's Healthcare Group have played a vital role in educating and developing medical professionals. All over the world, some of the leading practitioners in all areas of medical care and medical research credit their successful development to the early education and clinical training they have received in St. Vincent's. St. Vincent's University Hospital is one of the two major teaching hospitals affiliated to University College, Dublin.

While much has changed and been developed in that long period of service since 1834, the original values of Mother Mary Aikenhead are still promoted, implemented, and lived today within the St. Vincent's family. These values of human dignity, compassion, justice, quality, and advocacy are as important as ever.

Another critical matter which has not changed since St. Vincent's was founded in 1834 is the constant need for funds and the critical role of donors in helping us to continue to realise our world class potential. As a voluntary, not-for-profit hospital we rely on donors constantly, and the achievements and contributions of our supporters which are highlighted in this magazine are indeed heartening.

I thank everyone who has contributed in any way to St. Vincent's Foundation, and I hope you enjoy this magazine dedicated to the Friends of St. Vincent's. You are the modern day embodiment of a wonderful and rich tradition: bringing medical excellence, and clinical medical care to all.... irrespective of means or social position.

EstatesUpdate

St. Vincent's Campus is changing

Over recent months the SVUH hospital campus has seen a significant number of changes and relocation of services. The Herbert Wing inpatient floors are well on the way to be fully occupied.

As part of commissioning of both the Herbert Wing inpatient floors and the upcoming summer opening of the Nutley Wing a lot of careful planning has gone into the move of services.

Hospital Management identified designated Specialty Specific Bed Bases and in consultation with Clinical leads and Nursing have developed a new bed modelling strategy that focuses on best use of beds, with the emphasis very much on care and patient safety. This planning has included input from the supporting clinical services, ensuring that all our moves are clinically safe, and cause as little inconvenience to patients as possible.

This means a series of ward moves are currently underway and the final phase will be the commissioning of our new ward block. These moves will release valuable ward space for deep cleaning and allow minor repairs to be done. The adjacent wards will be restructured to incorporate the vacated spaces allowing the reduction from 6 bedded bays into 4 bedded units wherever possible.

One of the key benefits generated from all the moves has been the significant increase in single ensuite rooms available for patient use, improved patient environments overall and a better patient bathroom ratio.

Herbert Wing

Two of the Herbert Wing inpatient floors have reopened this month following some necessary works to meet hygiene and health and safety standards. The two new wards included a number of single ensuite bedrooms and 4 bedded rooms.

SVUH hopes that patients and family members will benefit greatly by the move to these new improved facilities and assure you that our priority will remain focussed on ensuring quality of care and patient dignity.

St Andrew's Ward - The new semi private ward is located on the 2nd floor.

St Pauls Ward - The 1st floor of the Herbert Wing has now been become the dedicated respiratory floor.

Everyone's support during this exciting phase of our campus development is greatly appreciated.

2012 focus will remain on improving facilities in patient related areas and we are working with the HSE to progress a number of capital projects such as the new ward block.

Improvements to Patient Facilities

You will be aware from previous editions that we have continued with our estates development projects where possible given the limited minor capital funding available to bring much needed improvements to patient facilities.

Donations of any amount will contribute to this programme and we are grateful for fundraising by families of patients that allowed us to buy some equipment that improved the environment and outcome for patients.

New Ward Block

Progress on site remains good and works are at advanced stages and level of finish is of a very high standard.

The external fascia of the building is now visible on the campus skyline and planning and preparation for the commissioning of the building is continuing in the background in preparation for a summer opening.

AMU Assessment Area and the Acute Medicine Unit (Short Stay Ward)

As part of the development of services under the National Clinical Program and future service planning for the Emergency Department the new AMU Assessment Area and the Acute Medicine Unit (Short Stay Ward) was opened recently.

With HSE funding the existing ED layout was redesigned to incorporate an AMU assessment area. A short stay ward (**Acute Medicine Unit**) was also opened in close proximity to the E.D. (Emergency Department)

Works included the relocation of some of the non clinical services to adjacent areas, upgrade of medical trunking, lighting, new flooring.

This has resulted in improved quality of care by consolidating and enlarging the existing facilities.

Endoscopy

We have created a new Endoscopy Unit. This involved the conversion of the old day ward in the Herbert wing into a purpose build facility which opened in January.

This development enabled development of a complete one way patient flow system, 3 procedure rooms, improved changing facilities, education facilities and new dedicated recovery beds. Also the new location allowed for the development of a one way decontamination system.

Since the completion of this work the overall feedback from patients, relatives and staff on their experience in the Unit has been extremely complimentary and positive and the staff were delighted to receive JAG accreditation so soon after their relocation.



Department of Dermatology Expansion Continues

The second phase of works has now been completed to expand the existing Dermatology department into a dedicated, standalone Dermatology Centre.

This new expanded unit has greatly improved the facilities with easy access to the main hospital, and incorporates Outpatient and Day Care facilities, expanded treatment facilities, improved patient environment and patient waiting areas.

This work is being enabled by the generous financial support of the Hume Street Trust. We are very grateful to them for contributing to this exciting initiative which will make a huge difference to the care of patients. as well as associated research and education.

History of St. Vincent's



Early Days

St Vincent's has cared for patients for more than 178 years.

In a series of articles in this magazine, we will set out some of the key milestones in that journey of care.

St Vincent's hospital was formed in 1834. Mother Mary Aikenhead saw the desperate conditions endured by the poor of Dublin and was determined to create a hospital that would cater for the sick regardless of their financial means.

At this time hospitals, where they existed, catered for the poor. The wealthy classes, when they got ill, were cared for in their own homes.

With a donation of £3,000, Mother Mary purchased number 56 St Stephen's Green from the Earl of Meath on January 23rd 1834. After a number of months of renovation the hospital accepted its first patients in April 1835. It was soon filled to capacity of twelve patients. A further eighteen beds were added later that year and in 1836 the capacity had increased to sixty patients. By 1850, the hospital had ninety beds.

Medical care was provided by Dr Joseph Michael O'Ferrall. He served the hospital tirelessly until his death in 1866 although almost completely blind in his later years. As well as being an outstanding physician Dr O'Ferrall was a pioneer in medical training and has left an account of the methods of teaching in St. Vincent's in the second half of the 1850's.

Dr O'Ferrall was joined on the medical staff shortly after the hospital opened by Dr O'Bryen Bellingham (known for his book, "Diseases of the Heart" published a few days after his death in 1857),

The service to patients, particularly less well-off has continued without interruption for almost 180 years during a period that saw major famine, two world wars and the 1916 uprising.

In later editions of **Friends of St. Vincent's** we will record other significant events in the life of the hospital.

The "Best Will in the World Week" held in October was a great success in highlighting the enormous contribution that can be made by including a favourite charity as a beneficiary when making a will.



The initiative, which was sponsored by St. Vincent's Foundation along with many other Irish Charities, included a subsidised or free consultation with participating solicitors. There are now solicitors in every county in Ireland who charge a maximum consultation fee of €50 for people who are considering making a will.

In Memory donations

As we have commented here before, many families ask for donations to a favourite charity in lieu of funeral flowers. The bereaved want the memories of their loved one to be reflected in a benefit to a worthy cause.

These "In Memory" donations are most welcome and very generous of families who look for others to benefit from their loss. This seems to be most effective when a collection box is placed in the church. We are often asked for suitable laminated signs for the collection box and we are happy to provide these on request.

We are very grateful for the donations we receive from relatives of deceased patients and also via our website. Often such donations are accompanied by kind comments about the staff who took care of the deceased and these are so appreciated also.

Tax Relief on Donations to St. Vincent's Foundation

Because St. Vincent's Foundation is an "Eligible Charity" as defined by the Irish Revenue Commissioners, donations of €250 or more in any one year are eligible for tax relief. The relief means that the Irish Revenue Commissioners repay the tax that is relevant to the donation. The tax relief is given at the donor's marginal tax rate (either 20% or 41%). The treatment of the tax differs between PAYE taxpayers and self-employed. The following examples demonstrate the benefits.

PAYE Donors

- St. Vincent's Foundation can seek the tax relief on the donation. Depending on the tax rate of the donor the following applies to a donation of €250:
- If the donor pays tax at 41%, St. Vincent's Foundation reclaims €174 thereby increasing the donation to €424 without any additional cost to the donor
- If the donor pays tax at 20%, St. Vincent's Foundation reclaims €62 which increases the donation to €312—again at no additional cost to the donor
- Larger donations attract a correspondingly increased tax refund.

Self-Employed Taxpayer

- The same level of tax relief applies as with PAYE taxpayers, but, in this case the refund is claimed by the taxpayer.

Some Medical news from St. Vincent's

ST. VINCENT'S HOSPITAL CHOSEN FOR EUROPEAN CANCER FELLOWSHIP PROGRAM

Since St. Vincent's Hospital was opened in 1834 its contribution to medical education has been considerable and it continues today.

Here we highlight a recent success.

St. Vincent's Hospital has been chosen as one of the three major teaching hospitals in Europe to provide hands-on Clinical Training to Oncologists who are coming to the end of their training period. This project is funded by the European School of Oncology, based in Milan and the other two teaching centres are the European Institute of Oncology in Milan and Institut Gustave Roussy, based in Paris. The Clinical Teaching Centre in St. Vincent's University Hospital/University College Dublin will initially be geared towards specialists in the field of breast, colorectal and hepato-pancreatico-biliary cancers and it is hoped that this will expand to other cancer types in the future.

Each Fellowship will be for a three month period in the first instance and can be extended to a six month period depending on the needs of the individual. Whilst most teaching modalities in Europe are based on conferencing, seminars and enduring educational materials this type of Fellowship is different in that it allows first hand experience of the trainee, with issues not alone relating to patient management, but also to the construct of specific cancer units, audit and quality assurance in cancer care.

This program will be advertised internationally in September 2012 and will be open to trainees from January 2013. Each of these three Clinical Teaching Centres in Europe will concentrate initially on differing areas in Oncology, such that the Institut Gustave Roussy in Paris will look mainly at Medical Oncology in differing cancer types, whilst St. Vincent's Hospital will initially concentrate on Surgical Oncology and hopefully expand into different disciplines in the future. It is anticipated that exposure to Multi Disciplinary Care Teams in these Centres will allow the trainees to return to their own countries and bring the experience necessary to allow them to set up and be part of their own specific cancer units. Therefore, there will be a follow-up program such that support will be available from the host institute such as St. Vincent's Hospital to the trainee to assist in career development and the establishment of cancer centres in their own country.
