## Welcome from Mr. Bill Maher, Acting C.E.O., St. Vincent's University Hospital

I am delighted to introduce this edition of our donors' magazine Friends of St Vincent's.

When I came to St.Vincent's in 2007 from the National Health Service in the UK, I was very conscious of the long tradition of medical care in the hospital. I learned about the unbroken service stretching over more than 170 years to the people of Dublin and the South-East.

What particularly impressed me was that the hospital didn't just attend to the immediate medical needs of the patients but extended to the totality of their needs including often the social service dimension. It was clear to me that the staff of St. Vincent's lived the values of the founding Sisters in 1835 of human dignity, compassion, justice, quality and advocacy.



I have been proud to become part of that tradition.

As a Voluntary, not-for-profit hospital, St. Vincent's cares for all patients equally regardless of their financial or social circumstances and always has done. From the beginning we were able to do this because of the generosity of donors who wanted to make a positive difference to those people who were, perhaps, less fortunate. Nowadays we receive much of our funding from the Department of Health but donor support remains vital if we are to achieve our world class potential.

In addition to our role within our catchment area, St. Vincent's is the National Centre for Liver Transplants, adult Cystic Fibrosis and Pancreatic Cancer as well as a key regional centre for many other areas of treatment. To give all of our patients the best chance of a positive outcome to their condition, it is essential that we provide our medical and caring staff with the best facilities we possibly can. This is a challenge in the best of times but particularly as funding becomes very challenging.

We have a number of projects underway; notable among them is the new ward block which will be completed early in 2012. This block, where every patient will be accommodated in a single room, is a model for modern healthcare and the very best environment for our patients. Our new Dermatology Centre will be opened before the end of this year and represents a major advance for patients. These and many smaller projects are assisted by donor support and we are grateful to each and every one of them – indeed, many could not progress without this essential support.

There are many urgent investments required in the hospital. A very current example is the dedicated Stroke Unit which we are currently fundraising for. At a cost of approx. €470,000, this unit when delivered will have the capacity to help an additional sixty patients to return to full independent living *each year*. This is a fantastic objective. We already have more than half the funds required to open this unit but we need just over €200,000 to deliver this unit.

I have been most impressed at the range of fundraising and donations on behalf of St. Vincent's Foundation. It really is a testimony to the creativity, energy and generosity of our patients, their families and friends. I want to assure all our donors that they make a real difference and there is tangible evidence of this through a number of projects, just some of which are mentioned in our Estates update in this magazine. Our Donors and fundraisers are true Friends of St. Vincent's and their donations never go unnoticed or unappreciated. To deliver the healthcare that we aspire to, we need all the support we can get and I am delighted to welcome our Friends to this edition of the magazine. I want to wish John Hickey and his colleagues every success on behalf of our patients for their ongoing efforts for St. Vincent's Foundation.

# **Estates Update**

## Update on improvements in St. Vincent's University Hospital.

We have continued in 2011 on an ambitious estates development programme that will bring further improvements to a wide range of patient facilities within the hospital.

Projects completed include the development of:

- ♦ Three new radiology reporting rooms
- Modifications to existing layout of the Cardiology Department / ECG to create additional offices and improve patient treatment areas
- Refurbishment and upgrade of Canteen Facilities for the benefit of patients and staff.



Some of our long term development projects under consideration include:

- Care of the Elderly Development of a dedicated Stroke Unit
- Upgrade of family accommodation in the St. Rita's building
- Acute Medicine Unit Existing Emergency Department layout to be redesigned and a further seven Admission lounges developed and relocation of non clinical services.

#### **Updates on some of our key Projects:**



#### **New Ward Block**

The new ward is due to open in late spring of 2012 and construction work continues to be on track.

Construction works are well advanced and has reached the 7<sup>th</sup> level.

#### **New Herbert Wing**

Following the relocation of the Private Hospital in late 2010 the hospital commenced on a extensive modification to facilitate the transfer of a number of services into the new wing.

Considerable works have been undertaken to date especially on the ground floor level of the building and a number of Clinical and Administrative Services have now been relocated.

The development of a new ADCC suite on the ground floor included the complete redesign and refurbishment of the original consultants' private clinic into 12 consultant rooms, 1 treatment room and supporting administration areas.

Work has also commenced on upgrading the inpatient floors and is expected to be completed by December 2011.





Long term this will help facilitate the hospital's Infection Control Strategy to increase the number of ensuite and single cubicle rooms available for patients and also reduce the number of 6 bedded ward bays to improve patient comfort and dignity.

#### **Department of Dermatology Expansion**

Upgrade and refurbishment works are well underway in the old OPD area adjacent to the current Dermatology Unit to facilitate the expansion of the Department.

City of Dublin Skin and Cancer Hospital (Hume Street) has funded this major upgrade and construction Project. Additional treatment rooms and supporting facilities were required to accommodate the expansion of the service.

Enabling activity, which included a number of clinical services and administration offices relocated to facilitate the works, have been completed over the last 4 months and the construction phase is now well underway.

#### STROKE UNIT FUNDRAISING

Staff in Our Lady's Ward recently presented proceeds from a number of fundraising events for the development of a Stroke Unit in St. Vincent's. These included the Connemara Half Marathon on 10<sup>th</sup> April, Wicklow 100/200 Cycle Race on 12<sup>th</sup> June, B.B.Q. in Fillies on 1<sup>st</sup> July and a Church Gate collection organised by staff member Jonathan O'Keeffe.







The Stroke Unit will cost approx €450,000 and we have already raised about half of this. The Stroke Unit will bring a huge improvement to the care we provide to patients affected by stroke. We estimate that approx 60 additional patients, each year, can be returned to full independent living through this initiative.

A brave St. Vincent's team took part in the Wicklow 100 and 200 cycling events on June 12<sup>th</sup> last for the Stroke Unit in St.. Vincent's University Hospital. This was one of the worst days of the year and the team showed remarkable resilience to complete the courses despite the cold and wet.

They were joined by junior doctors, nurses and staff from all areas of the hospital. It was the greatest collaborative effort by staff to support a single project in the hospital.

## Bequests & Gifts to St. Vincent's

### Legacy Activity

We previously highlighted the importance of legacies in enabling projects in St. Vincent's since the hospital was established in 1834 and we are delighted that this support continues.

Recognising the importance of legacy gifts, some of the biggest charities throughout the world have come together this year and established September 13<sup>th</sup> as International Legacy Giving Day. Participating countries include Australia, Canada, Spain, Switzerland, U.K. and many many others. In Ireland the movement is through Legacy Promotion Ireland.



According to recent Irish research, only one in three Irish adults make a Will. Furthermore, only 12% of Irish people indicate that they have included a charity as a beneficiary in their Will, despite the fact that 62% of Irish people say they would consider leaving a gift to charity in their Will. Legacy donations are an extremely valuable source of unrestricted income to charities. However Irish charities only raise approximately 6% of their income from legacies which compares to up to 40% in the UK. Indeed, many Irish charities have never received a bequest.

Legacy Promotion is an organisation of a wide range of over 60 Irish charities which aims to raise public awareness of the importance of making a Will and leaving charitable bequests in Wills through an on-going campaign.

This year Legacy Promotion Ireland has run an extensive advertising campaign on TV, radio and in the newspapers highlighting the benefits of legacies. The campaign makes a number of key points:

- ♦ Leaving a gift in your Will to your favourite charity is easy
- ♦ Your gift doesn't have to be a big cash gift e.g. 1% of your estate
- ♦ Leaving a gift in your Will to your favourite charity will have a lasting impact

Anyone making or amending a Will is advised to use the services of a solicitor to ensure that their wishes are clear and will be carried out accordingly. Legacy Promotion Ireland has got support from a wide range of solicitors who have offered a client consultation for a minimal fee and in some cases no fee at all when someone is considering including a charity as a beneficiary in their Will.

### In Memory donations

There is a growing trend of families suggesting "In Memory" donations to specific causes in St. Vincent's in lieu of funeral flowers. This is welcome and very generous of families who look for others to benefit from their loss. We are very grateful for the donations we receive from relatives of deceased patients and also via our website.

#### Tax Relief on Donations to St. Vincent's Foundation

Because St. Vincent's Foundation is an "Eligible Charity" as defined by the Irish Revenue Commissioners, donations of €250 or more in any one year are eligible for tax relief. This relief applies if donations of €21 or more per month are made by standing order. The relief means that the Irish Revenue Commissioners repay the tax that is relevant to the donation. The tax relief is given at the donor's marginal tax rate (either 20% or 41%). The treatment of the tax differs between PAYE taxpayers and self-employed. The following examples demonstrate the benefits.

#### **PAYE Donors**

- St. Vincent's Foundation can seek the tax relief on the donation. Depending on the tax rate of the donor the following applies to a donation of €250:
- If the donor pays tax at 41%, St. Vincent's Foundation reclaims €174 thereby increasing the donation to €424 without any additional cost to the donor
- If the donor pays tax at 20%, St. Vincent's Foundation reclaims €62 which increases the donation to €312—again at no additional cost to the donor
- Larger donations attract a correspondingly increased tax refund.

#### Self--Employed Taxpayer

• The same level of tax relief applies as with PAYE taxpayers, but, in this case the refund is claimed by the taxpayer.

## Some Medical Highlights from St. Vincent's

SVUH obtains research funding to study incontinence

Faecal incontinence affects some 8 to 12% of the population to some degree. It is a very debilitating condition and may lead to social isolation. Women who have a history of difficult childbirth are most likely to be effected and the condition may be associated with other disorders of the pelvic floor such as prolapse or urinary incontinence. In collaboration with Prof Colm O'Herlihy at the National Maternity Hospital and Dr James Jones, Senior Lecturer in Physiology at UCD School of Medicine and Medical Science, Prof. Ronan O'Connell has a long established research group which has investigated the underlying mechanisms of injury during and after childbirth. Recently,

sacral nerve neuromodulation has been introduced for the treatment of patients with incapacitating incontinence with excellent results. The group has now secured more than €200,000 in external research funding from Science Foundation Ireland and the Bowel Disease Research Foundation of Great Britain to study the mechanisms by which neuromodulation works in the treatment of faecal incontinence. Collaborative research projects have also been established with colleagues in Trinity College Dublin and the Royal London Hospital.



## **Centre for Colorectal Disease Meeting**

The Centre for Colorectal Disease at St. Vincent's Hospital was established to ensure integration of medical and surgical treatment, education and research relating to diseases of the colon and rectum - the large bowel - at St. Vincent's University, St. Michael's and St. Vincent's Private Hospitals. The Centre brings together the collective expertise of gastroenterologists, colorectal surgeons, radiologists, oncologists, pathologists, specialist nurses and dieticians to provide multidisciplinary care for patients supported by nursing and administrative staff.

# Some Medical Highlights from St. Vincent's contd...

The annual International meeting provides a forum to share the Centre's clinical and research experience with doctors, nurses, dieticians, scientists and students. The 18<sup>th</sup> meeting was held on 9<sup>th</sup> Sept. with the theme 'Old problems – New solutions'. The title reflects the difficulties of and recent advances in the treatment of colorectal cancer at the two ends of the clinical spectrum: early disease in which minimal surgical techniques may be used to avoid major operations and advanced disease in which more radical surgery may achieve long term survival and even cure when it might not previously have been possible.

Each year notable international speakers are invited and the list includes some of the world's most highly regarded clinicians involved in colorectal diseases.

This year Dr Nick West, a pathologist from Leeds in UK, spoke on how detailed assessment of tissues removed at the time of surgery can be used to predict cancer outcome and also act as a measure of quality assurance. Mr. Jurgen Mulsow, just returned from a fellowship at the University of Erlangen, Germany, described ultra radical surgical techniques used in Erlangen to treat colon cancer, while Mr Dara Kavanagh, spoke on the St. Vincent's experience in introducing more radical surgery for patients with advanced rectal cancer. Mr David Beddy, consultant surgeon, discussed the potentially curative effects of radiotherapy on rectal cancer, while Prof Des Winter considered whether it is possible to avoid removal of the rectum in certain patients with cancer. Dr Glen Doherty, consultant gastroenterologist, presented on new techniques for endoscopic removal of cancerous polyps and other early tumours. Such techniques are of particular importance in the treatment of tumours such as those identified by screening for colorectal cancer – soon to be introduced in Ireland.

The state of the art lecture was given by Mr Brendan Moran lead surgeon at the Colorectal Unit at Basingstoke Hospital, UK which is one of only two centres in the UK or Ireland funded for the treatment of advanced intra-peritoneal malignancy due to carcinoma of the appendix. Every year 3 to 5 Irish patients are referred to Basingstoke for specialist treatment. Mr Moran presented data on recent advances in the surgical and oncological management of advanced peritoneal malignancy in patients with colon cancer, a situation that has up until now always been considered incurable.
